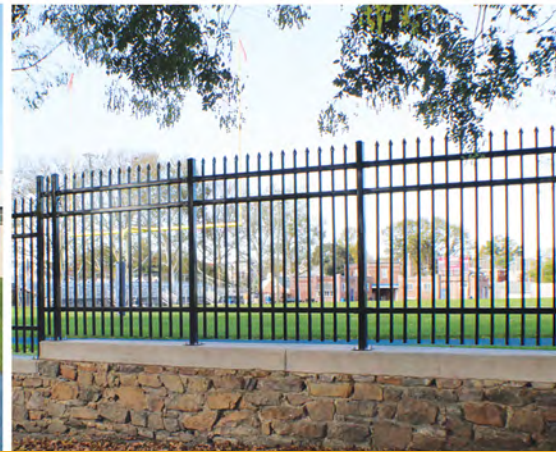

CONSHOHOCKEN CITIZEN SURVEY REPORT RESULTS ARE IN!

Residents of the Conshohocken Borough can now view the full reports and feedback compiled from the community survey conducted this past August. All reports can be found on the Borough website at www.conshohockenpa.gov.

The Borough worked closely with the National Research Center (NRC) to complete a National Citizen Survey (NCS) tailored specifically to the Borough of Conshohocken. The survey consisted of 6 pages, and all questions were in a multiple-choice format. Survey questions asked residents to rate their experiences related to eight categories pertaining to the quality of life in Conshohocken. These components included: Safety, Mobility, Natural Environment, Built Environment, Economy, Recreation and Wellness, Education and Enrichment, and Community Engagement. Overall 95% of Conshohocken residents rated the Borough as an excellent or good place to live, and at least 7 in 10 residents felt favorably about most aspects of the community.

Within the eight facets of community, at least 9 in 10 residents gave favorable evaluations of Safety characteristics, similar to national benchmarks. Residents tended to rate aspects of Mobility as similar to or higher than national averages and at least half of respondents awarded favorable scores to most measures. Borough respondents were especially engaged in activities related to Mobility; about two-thirds indicated they had used public transportation instead of driving and about 8 in 10 had walked or biked instead of driving. However, residents were less pleased with public parking and traffic flow and these ratings were lower than communities elsewhere.

Within Economy, the vibrancy of the downtown area, employment opportunities and the Borough as a place to work all stood above the benchmark; all other aspects were similar to the comparison communities except for shopping opportunities, which was rated lower than the national average. All aspects of Natural Environment, Built Environment, Recreation and Wellness and Community Engagement were similar to other municipalities nationally. Within Education and Enrichment, all were on par with the benchmark, with the exception of two areas, opportunities to attend cultural/arts/music activities and adult education, which residents rated below the national averages.

Overall residents identified Safety, Built Environment and Economy as priorities in the coming two years. In addition, approximately 9 in 10 survey respondents identified improving traffic and road conditions to be essential or very important and at least half placed high importance on improving public transportation. Furthermore, close to 8 in 10 reported that protecting natural resources and growth management were priorities. Less than half of participants thought providing additional community recreation facilities or increasing the amount of activities for seniors was essential or very important.

The NCS results will serve as a valuable resource to Borough Council and the Comprehensive Plan Task Force, who is currently in the process of creating a 10-year operating plan for Conshohocken.

“It is not surprising to me that 95% of residents rated the Borough of Conshohocken as an excellent or good place to live. More importantly, the data provides valuable insight into resident identified priorities: Safety, Built Environment and Economy. This data is invaluable because it highlights characteristics of the community that matter most to residents specifically the areas of operation where we need to focus our attention and make improvements” said Borough Manager Stephanie Cecco. “We thank all residents who participated in the community survey.

The Borough and the NRC finalized all survey materials in late July 2017. The survey was conducted using two methods. The first was through mail. The NRC randomly selected households within Conshohocken Borough limits. Notifications regarding the survey’s release were announced on the Borough website and via post cards in early August. A copy of the mailed survey was sent to households on August 11, 2017 and August 18, 2017.

The second method was an opt-in online survey, which was available to all other residents on September 8, 2017 through the Borough website. The data collection period for both the mailed survey and online opt-in survey ended on October 6, 2017. The Borough of Conshohocken would like to thank all who participated! Overall, the Borough’s response rate was above average at 30%.

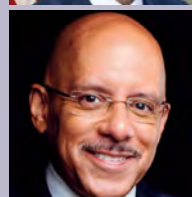

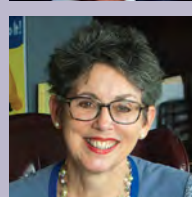

Dear Neighbors,

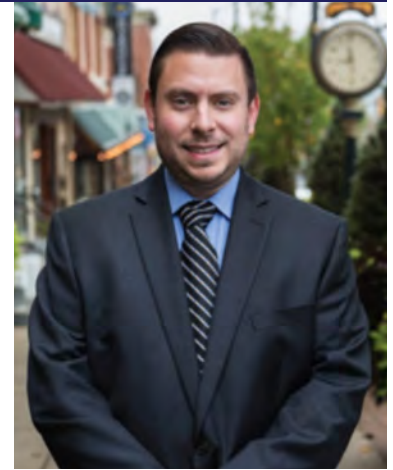

DRIVEWAY AND ROOFING SCAMS

The warmer weather months of spring and early summer see an uptick in certain crimes. Driveway sealing and roof coating scams become more prevalent. These usually involve an unsolicited offer from someone who stops at your residence. They offer to seal/coat your driveway or roof and require payment up front. They will offer themselves as a legitimate contractor and may have a truck with some type of tank in the back. More often than not, they will take the money and do nothing or apply an inferior product, which is not a legitimate sealant. In some cases, they will start the work while a cohort cashes the check and once that occurs, abandon the job. All contractors operating in the Borough of Conshohocken are required to be licensed and you have a right to see their license. It is my recommendation not to hire any unsolicited contractor. Watch out for your neighbors, especially the elderly who are targeted by scammers and please if any suspicion arise call us and we will be happy to verify the legitimacy of that person.



FIREARM SAFETY COURSE

FIRE AND EMERGENCY SERVICES

FIRE PREVENTION REMINDERS

- Install smoke alarms on every level of your home, inside bedrooms and outside sleeping areas.
- Test smoke and carbon monoxide detectors once a month.
- Talk with all family members about a fire escape plan and practice the plan twice a year.
- If a fire occurs in your home, GET OUT, STAY OUT and CALL 911.
- Practice STOP, DROP and ROLL.
- Keep anything that can catch fire — oven mitts, wooden utensils, food packaging, towels or curtains, away from your stovetop.
- Make sure you clean the lint filter before or after each load of laundry.
- Have a meeting place outside the residence, so everyone can be accounted for.



SMOKE AND CARBON MONOXIDE DETECTORS

- Install smoke alarms inside and outside each bedroom and sleeping area. Install alarms on every level of the home. Install alarms in the basement.
- Test all smoke alarms at least once a month.
- Carbon Monoxide detectors should be installed on every level, on the ceiling by stairwells.
- If the Carbon Monoxide alarm sounds, immediately move to a fresh air location outdoors. Make sure everyone inside the home is accounted for. Call 911 from a fresh air location and stay there until emergency personnel arrive.
- Gas or charcoal grills, and generators produce Carbon Monoxide — they are for outside use only.

HEATER SAFETY

- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Keep anything that can burn at least five-feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Space heaters should be turned off and unplugged when you leave the room or go to bed.
- If you smell natural gas inside your residence, move to fresh air location and call 911.



WOOD BURNING STOVES & FIREPLACES

- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room.
- Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- Have your chimney and stove inspected and cleaned by a certified chimney sweep every fall just before heating season.
- Backyard fire pits must be kept 15 feet away from any combustible material. Make sure smoke from fire pits and chimneys do not make a nuisance to your neighbors.

CANDLES & HOLIDAY DECORATIONS

- Use a battery-operated candle or glow-stick in jack-o-lanterns.
- Never use lit candles to decorate the tree.
- Always turn off Christmas tree lights before leaving home or going to bed.

FAIR HOUSING FOR PEOPLE WITH DISABILITIES

Do you have a physical, mental or emotional condition, which limits one or more activities of daily living? Do you use a walker, wheelchair, service animal, or a personal care attendant? Do you rent your dwelling? If so, you are protected under the Fair Housing Amendments Act of 1968 as amended.

The Fair Housing Act prohibits discrimination in the sale or rental of housing. Illegal practices include refusing to sell or rent to someone with a disability; refusal to negotiate for housing; making housing unavailable or telling a prospective renter or buyer that housing is not available; discriminatory advertising; and threatening anyone exercising their fair housing rights or anyone who assists someone who is exercising their fair housing rights. Additionally and most importantly for an individual with disabilities, it is illegal to refuse to make reasonable accommodations for individuals with disabilities or to refuse to permit a tenant with a disability to make reasonable modifications to their home at their own expense.

Reasonable accommodations are changes to rules, policies, or general services that enable a person with a disability to fully use and enjoy their home. Examples of such accommodations would be assigning a mail box on the lowest level of boxes to a person who uses a wheelchair; allowing individuals with assistive animals to have the animal where there is a no pet policy, not charging a fee for an assistive animal that is not charged to all other animal owners; or assigning parking spaces in close proximity to the entrance to a building or the elevator in a building for individuals who have difficulty walking.

People with disabilities have the right to make reasonable modifications to their dwelling to enable them to use the dwelling's features appropriately. For example, an individual may require grab bars to use the bathroom facilities; lower cabinets or sinks may be needed in the kitchen by an individual using a wheelchair; a ramp may be needed to access a building or a laundry room; or a deaf individual may require a lighted doorbell to know when there is someone at the door. In most instances the tenant of the unit is required to pay for the modifications, unless the building receives federal assistance. Also, the disabled individual may be required to remove the modifications and return the unit to its original condition, when they move.

NEW HOUSING REHABILITATION INCOME GUIDELINES

The U. S. Department of Housing and Urban Development (HUD) has issued new income eligibility guidelines for Conshohocken's Housing Rehabilitation Program. Conshohocken's Housing Rehabilitation Program provides services to low and moderate income residents to bring their properties into compliance with the local building code and established housing quality standards.

Eligible repairs include: roof repair, window repair or replacement, heater replacement, electrical upgrades, plumbing improvements, kitchen improvements, accessibility improvements, exterior concrete, and other repairs that are not solely aesthetic in nature, such as general painting of a house.

The Department's staff is responsible to promote proactive property maintenance and regulate business activities through the issuance of permits, licenses and certificates, and conducting appropriate inspections to ensure compliance with applicable ordinances and codes adopted by the Borough. FREQUENTLY ASKED QUESTIONS

Do I need a permit for.....?

Any work beyond a basic repair or a non-structural alteration may require a building permit issued by the Borough's Building Code Official for both residential and commercial properties. The best course of action is to contact the Borough office at (610) 828-1092, and ask a building inspector if a permit is required for your project. Be prepared to provide a detailed scope of work for the project, and identify the property as residential or commercial. Change in use may require Zoning approval.

Am I responsible for maintaining the alley behind my house?

Yes. Typically, the property owners on each side of an alley are responsible to maintain to the center of the alley for the width of each respective property. This includes the alley pavement surface (e.g. potholes), as well as grass, weeds, trash, etc., that may be found in an alley, regardless of how it ended up there. Weeds on the other side of your fence along the alley are still part of your property, and therefore your responsibility to trim and/or spray. The Borough does not plow snow in alleys.

LICENSES & INSPECTIONS CONTINUED

Why does the Borough need to inspect the home I'm selling?

Borough Ordinance Chapter 11, Part 1 governs Transfer of Real Estate and Real Estate Certification. Anyone selling a property in the Borough is responsible to certify, according to §11-111, that there are no uncorrected violations of any housing, building, zoning, safety or fire codes. The Borough performs an inspection based on a Real Estate Certification Checklist (<http://www.conshohockenpa.gov/media/24006/Real-Estate-Checklist-52617.pdf>) adopted by Borough Council and records any apparent violations. All violations are required to be corrected prior to settlement, or the responsibility to correct said violations may be transferred to the buyer, who will have 12 months to complete the work. The terms of such a transfer are private and fall outside of the Borough's authority.

Where exactly is my property line?

Absent physically apparent monuments or property corner pins, the Borough cannot independently verify property lines on behalf of private property owners. Property owners are encouraged to engage a Professional Land Surveyor to prepare a site plan and physically set corner markers. This information is useful for locating potential property improvements such as fences and garages, laying out additions to the primary structure, and to satisfy property line disputes, if necessary. Plans for newer homes may be available at the Borough office. File a Right-to-Know Request, and the Borough staff will search the archives.

How do I register a new rental property?

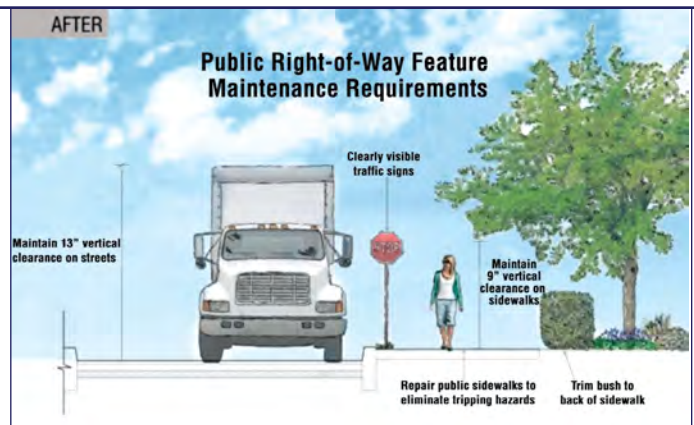

The newly formed Conshohocken Dog Park Committee consists of nine appointed residents who work together to ensure the Dog Parks in Conshohocken are appropriately maintained and improved. The committee members had their first meeting in October and in just a few short months have helped to get lights installed at the Riverside Dog Park and are working to map out a future plan for the Haines-Salvati Memorial Dog Park.

PUBLIC SERVICES

SNOW REMOVAL

When it snows it is the Public Services Department's goal to have all Borough and State roads cleared within 6 to 10 hours after the snow has stopped falling. If you have off street parking please refrain from parking on the street. This will help our crews do a better job. Clear your sidewalks after plowing has been completed. A 3 foot wide path of sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your crosswalks, handicapped ramps, and alley crossing. It is illegal to shovel, throw or plow snow from sidewalks onto street parking, driveways and allies into the street or right-of way. Dumping snow or ice on Borough property, or plowing snow across a street is also prohibited.

When a snow emergency has been declared by the Mayor, remember to remove your vehicle from any posted "Snow Emergency Route." Your vehicles must be removed until after the parking lanes have been completely cleared.

2018 HOLIDAY SOLID WASTE & RECYCLE COLLECTION SCHEDULE

When a Holiday falls on a Saturday or a Sunday it is observed on the following Monday. When your trash and recycle collection day falls on a holiday, your trash and recyclables will be collected on your next scheduled collection day. If the holiday is on a Monday there will be no trash collection. Trash for the West Side and recyclables only for the East Side will be picked up on Tuesday following the Monday holiday.

TRASH COLLECTION RULES AND REGULATIONS

- There is a limit of 4 cans/bags per household per pick-up (200 pounds maximum)
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Please place your cans/bags at curbside on your property no earlier than 5:00PM the night before and your cans must be removed from curbside no later than 7:00PM the day of collection.
- No clean-outs or move-outs unless prearranged 24 hours in advance. Please call 610-828-1092.
- No construction debris or carpet unless prearranged 24 hours in advance. Please call 610-828-1092.
- Trash will be left curbside and 'red tagged' if deemed to be too heavy or improperly placed. Trash that is left should be returned to the property before 7:00 PM.

YARD WASTE COLLECTION RULES AND REGULATIONS:

All residences must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable, therefore the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Grass clippings, weeds, leaves, brush and plants should be placed in biodegradable paper composting bags. Please no trash in these bags.
- Each bag should not to be heavier than 50 pounds.
- Tree branches under five-(5") in diameter, not exceeding five-(5') in length, are to be securely tied into bundles and should not to be heavier than 50 pounds.
- Christmas trees. Please no decorations, tree stands or plastic tree bags.
- Please place your bags and or bundles at curbside on your property no earlier than 5:00 PM the night before.
- There is no limit of yard waste collected that is determined to be reasonable by the Borough.

CONSHOHOCKEN IS SINGLE STREAM RECYCLING

Conshohocken's Single Stream Recycling process allows all of your recyclable materials to be placed into one recycling container. The best part is you don't have to separate them. Hence we get the term 'Single Stream Recycling'.

Residents will see trash trucks collecting your recyclables. Rest assured the recycled materials are going to the recycling facility, NOT the trash-to-steam plant. Make sure your recycling container is left out before 7am on collection day, at the front edge of your property or nominated collection point.



RECYCLING BINS WILL NOW BE DELIVERED EVERY WEDNESDAY!

Public Services will be replacing old and damaged recycling bins with new ones every Wednesday on a regular basis at no cost to the residents. PUBLIC SERVICES ACHIEVEMENTS IN 2017

As you may have noticed, the Public Services crew has been working hard to update many of the areas around you. Some of the major projects that were completed in 2017 included:

- Installation of the new park equipment at Sutcliffe Park
- Completion of the Second Avenue Meadows park installation
- Installation of the new walking/jogging track at the "A"- Field
- Addition of a new parking lot located next to the "B"- Field
- Treatment of 21 ash trees to protect and preserve the trees against the emerald ash borer (EAB), a beetle, whose larvae feed on the inner bark of ash trees. Several Public Services employees completed training and received certification in order to complete this
- Completion of the East Hector Street re-greening project on the 300 and 400 block of East Hector Street
- All of the street lines throughout the Borough were repainted along with the addition of new safety crosswalks using 3M high visibility material
- Interior improvements were made to the Public Services building including installation of LED lights and the addition of a new training room for the employees

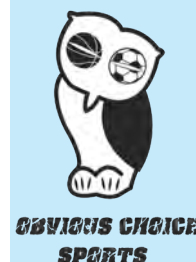

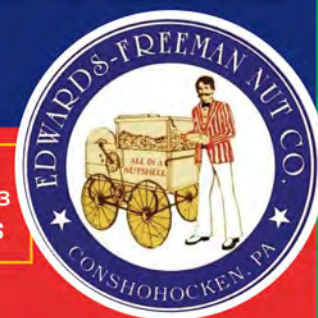
