POCKET PARKS ARE COMING TO CONSHOHOCKEN

Two new pocket parks will be constructed in 2023 after receiving approval from the Borough Council in November 2022. One pocket park will be on the grounds of the Fritz Lodge, located at 801 Fayette Street. The other pocket park will be located near the corner of Fayette Street and West 6th Avenue, in between the Conshohocken United Methodist Church and Santander Bank.

With the addition of the two pocket parks, the roster of parks in the Borough increases.

The Fritz Lodge Pocket Park will include a walking path, lighting, benches, a potential digital sign, and a renovated parking lot. The Santander Pocket Park features a garden area with flowers, small trees, and benches.

The pocket parks will help increase the walkability of Fayette Street. They will also preserve and enhance the Borough's green infrastructure.

SUTCLIFFE PARK NOTE

Keep an eye on Sutcliffe Park during the coming months. Conshohocken has received funds from the Pennsylvania Department of Conservation and Natural Resources and the Commonwealth Finance Agency that will enable the Borough to renovate the walking trail.

The project will correct cracks and upheavals in the trail bed, fix the pooling of water in several locations, and add an additional trail loop. There will be two new access points from the surrounding neighborhoods on the east and west sides of the park. Benches will be installed, and there will be new signage describing the trail and the distances of its various loops.

Stay tuned for further information about the project's development and timetable.

Spring is here, and it's time to clean out your cabinets. Did you know that the Conshohocken Police Department has a medication drop box for unwanted or expired medications? Unwanted medications should be deposited in the labeled drop box located in the lobby of the Conshohocken Police Station. Prescription pills and patches, over-the-counter medications, vitamins, samples, and pet medicine are accepted. We do not accept inhalers, thermometers, needles, medications from businesses or clinics, hydrogen peroxide, ointments, lotions, liquids, or aerosol cans.

There is also a shred bin available in the police lobby for any unwanted documents or paperwork.

The police lobby is open Monday- Friday from 8 a.m. to 4 p.m.

Along with notifying us of your absence, here are a few other safety measures you will want to follow.

Safety Measures

- Notify a friend, relative, or trusted neighbor that you'll be away and leave emergency phone numbers with them in case they need to reach you.
- Be sure all your doors, windows, and gates are locked when you leave.
- Be sure to stop your mail and your deliveries or have a friend, relative, or trusted neighbor bring it in for you daily.
- Put a couple of indoor lights and outdoor lights on a light timer – this gives the illusion someone is home.
- Arrange for someone to take care of your lawn while you're away.

What is stormwater?

Stormwater is water from rain or when snow and ice melt that seeps into the ground and flows across the ground and pavement.

This precipitation is an important part of nature's water cycle and replenishes drinking water supplies, recreation, and healthy wildlife habitat. However, it can become a problem when pollutants from activities such as car maintenance, lawn care, and dog walking are left on the ground for rain to wash away or when it causes flooding and erosion of stream banks.

When stormwater doesn't seep into the ground, stormwater drains into what are called storm sewers. These include the drains near street corners or at low points on the sides of streets. The drains connect through a system of pipes that make up the storm sewer system and eventually flow directly into the Plymouth Creek and Schuylkill River. All of the pollutants stormwater carries along the way empty into the river because stormwater does not get treated.

What you can do to help reduce stormwater pollution:

- Properly dispose of hazardous substances such as used oil, cleaning supplies, and paint. Never pour them down any part of the storm sewer system. Report any such disposal you see to the Borough.

- Use pesticides, fertilizers, and herbicides properly and efficiently to prevent excess from running off.
- Look for signs of soil and debris leaving construction sites in stormwater runoff or tracked into roads by construction vehicles. Report any of these conditions to the Borough.
- Report any stormwater discharges into the Plymouth Creek or Schuylkill River during times of dry weather to the Borough. This may be sign that there is an issue with the storm sewer system.
- Pick up after pets and dispose of their waste properly. No matter where pets make a mess – in a backyard, at a park, or near the road – stormwater runoff can carry pet waste from the land, to the storm sewer system, to the River.
- Store materials that could pollute stormwater indoors and use containers for outdoor storage that do not rust or leak to eliminate exposure of materials to stormwater.

HOUSING REHABILITATION PROGRAM

Conshohocken's Housing Rehabilitation Program has available funding to bring the homes of low and moderate-income residents into code compliance. The Program has been in existence for over five decades and has assisted hundreds of residents to remain comfortably and safely in their homes.

Rehabilitation activities may include roof repair, window and door replacement, electrical upgrades, sidewalk repair, plumbing repairs, and kitchen and bathroom improvements. Accessibility improvements, such as grab bars and ramps, also are eligible activities.

The Housing Rehabilitation Program operates as a four-year deferred payment loan for the cost of construction. 25% of the loan is forgiven for each year the owner remains in the home. After four years of living in the home, the entire loan is forgiven. Please know that there is no cost to the homeowner unless the home is sold or leased within four years of the final rehabilitation inspection.

LICENSES & INSPECTIONS

Licenses & Inspections is responsible for the administration and enforcement of Borough ordinances, along with Federal and State building codes. These ordinances may pertain to building, zoning, land development, housing, and property maintenance.

It also responds to citizen complaints concerning property maintenance (lawn maintenance, snow removal, etc.); construction project inspections; apartment inspections; curb and sidewalk inspections, and applications regarding building projects. Licenses & Inspections issues permits for Use and Occupancy, repairs, replacements, additions, and new installations of boilers, roofs, etc.

Licenses & Inspections works closely with the Police Department and the Borough's Fire Marshal in the resolution of health and safety issues as well as residential nuisance complaints on a day-to-day basis.

ZONING SERVICES

The rules for each zoning district are outlined in the Borough's Zoning Ordinance (<https://ecode360.com/14317188>). The zoning ordinance determines the specific land uses that are permitted in each district, such as residential, office, commercial, or industrial. The code also outlines the dimensional standards in each district, such as maximum building and impervious coverage, minimum building setbacks, and maximum building heights.

Zoning Permits:

The Zoning Ordinance includes regulations governing off-street parking, patios, walkways, signs, fences, and accessory structures. Please note the above mentioned require zoning permits. The Zoning Permit application is found on the Borough's website, www.conshohockenpa.gov. The permit fee is a flat fee of \$50.00, and permits require two weeks to process for completed applications.

Zoning Hearing Board Applications:

The Zoning Hearing Board conducts public hearings at the request of developers and residents seeking zoning relief from a provision of the zoning ordinance via variance or special exception. The Board meets when an application and/or zoning petition has been submitted with all applicable documentation and fees. The Zoning Hearing Board reviews applications on a case-by-case basis and makes determinations based on the Borough's Zoning ordinance. Meeting dates, changes and/or cancellations are reflected on the Borough's website.

Short-Term Residential Rental (Transient Lodging):

Per the Conshohocken Borough Code, the rental of a residential property for a period of less than 30 days constitutes transient lodging and is not permitted in the Borough. Therefore, the operation of a short-term residential rental (transient lodging) constitutes a zoning violation.

FIRE SERVICES

Sprinkler Nights

Beat the summer heat by joining us at the parks for our Sprinkler Nights! You can meet our firefighters, tour the fire trucks and shoot the fire hose. Don't forget to wear your bathing suit! Dates and times will be announced on the Borough website and social media outlets.

Free Smoke Detectors & Installation

Free smoke detectors are available for residential property owners for pick-up at Borough Hall (400 Fayette Street, Suite 200). Supplies are limited to three (3) smoke detectors per household. Residents that require assistance with the installation of smoke detectors can contact Fire Chief Tim Gunning for arrangements.

Fire Safety Tips

Smoke Alarms

- Smoke alarms should be installed on every level of your home, inside and outside of sleeping areas.
- Smoke alarms should be tested monthly and batteries should be changed every six (6) months.
- Smoke alarms should be replaced every 10 years.

Carbon Monoxide Alarms

- Carbon Monoxide alarms should be installed on every level and tested on a monthly basis.
- Carbon Monoxide alarms should be replaced every seven (7) years.

Summer Safety

- Fireworks and sparklers can cause fires, burns dismemberment, or death if handled improperly. Pennsylvania residents are permitted to purchase and use consumer-grade fireworks that contain a maximum of 50 milligrams of explosive material. The use or discharge of all display fireworks or sparklers is prohibited on Borough property and parks.
- Propane, charcoal, and wood pellet barbecue grills should be used outdoors only. Indoor use can cause fire or carbon monoxide poisoning.
- Grills, chimineas, outdoor fireplaces, and fire pits should be at least 10 feet away from your home or anything that can burn. These items should not be stored or used on porches or balconies.

Trash & Recycling Cart Updates

Borough-approved containers must be used for all residential trash and recycling, unless other arrangements have been made and approved by the Public Services Department. Trash and recycling cans must have 2 wheels, a metal lift bar, and attached lid. Unapproved containers will be tagged for no future pickups until the residence comes into compliance.

Trash Collection Rules and Regulations

- There is a limit of four (4) cans/bags per household per pick-up (200 pounds maximum)
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances, and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Each household is permitted to dispose of one (1) large piece of furniture or bulk item per month with regular trash. This includes sofas, box springs, plastic siding, TVs and all electronics. All other bulk trash or bulk metal collection must be arranged through the Borough of Conshohocken by calling 610-828-1092.
- Please place your cans/bags at curbside on your property no earlier than 5:00 PM the night before and your cans must be removed from curbside no later than 7:00 PM the day of collection.
- No construction debris, carpet, clean-outs, or move-outs unless approved by the Licenses and Inspections Department. Please call 610-828-1092.

Conshohocken Is Single Stream Recycling

Single stream recycling allows all your recyclable materials to be placed into one recycling container. The best part is you do not have to separate them! Hence, we get the term '*Single Stream Recycling*.' Residents will see trash trucks collecting recyclables. Rest assured recycled materials will go to the recycling facility, NOT the trash-to-steam plant. Recycling carts should be left out before 7:00 AM on collection day, at the front edge of your property or nominated collection point.

Yard Waste Collection Rules and Regulations

Yard waste stickers are available at the Borough office to convert your old blue recycle bin into a container for yard waste disposal.

All residents must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable; therefore, the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Weeds, leaves, brush, and plants should be placed in biodegradable paper composting bags. Please, no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five (5") in diameter, not exceeding five (5') in length, are to be securely tied into bundles and should not be heavier than 50 pounds.
- Christmas trees. No decorations, tree stands or plastic tree bags.
- Please place your bags, and/or bundles at curbside on your property no earlier than 5:00 PM the night before.

Christmas Tree Recycling

Public Works collects Christmas trees each year following the holiday. Christmas trees should be placed curbside the Tuesday before yard waste collection. The trees are collected, chipped, and composted. All tree bags, ornaments, lights, and stands must be removed.

Snow Removal

Efficient snow removal helps ensure the safety of our residents, visitors, and those traveling through the Borough. When it snows, Public Services makes every effort to clear all Borough and state roads within six (6) to 10 hours after snow has stopped falling. Public Services utilizes a snow management plan that consists of pre-treating roads with a brine solution and plowing during and after a snowstorm. Please refrain from parking on the street if you have off-street parking available.

Plowing

Residents with off-street parking should refrain from parking on the street so that Public Services can clear more of the road. Cones, lawn chairs or other objects used to reserve parking spaces during a snowstorm are prohibited. Public Services will not stop plowing to remove objects used to reserve parking spaces.

State and Local Roads

Public Services is responsible for plowing all local and state (PennDOT) owned roads, including the Matsonford Bridge and train station cross walks within the Borough of Conshohocken. SEPTA is responsible for clearing snow from the train station and all steps and/or staircases accessing the train station.

Declared Snow Emergency

When the Mayor declares a snow emergency, residents are required to remove their vehicles from any of the Snow Emergency Routes designated below. During a declared snow emergency parking is restricted in these areas and vehicles may be towed.



Snow Emergency Routes

- Fayette Street, both sides from the Conshohocken Borough line to the bridge.
- The south side of Freedley Street from 12th to 11th Avenues.
- Poplar Street from Elm Street to Washington Street.
- East First Ave. (Harry Street to Fayette Street)
- West First Ave. (Fayette Street to Forrest Street)

Snow Removal Reminders for Residents

- Residents should clear their sidewalks after plowing has been completed.
- **It is illegal to shovel, throw or plow snow from sidewalks onto street parking, driveways, allies and into the street or right-of way.**
- Please use caution while shoveling heavy, deep snow from your property.
- A 3-foot-wide path on the sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your crosswalks, handicapped ramps, and alley crossing. The Borough does not plow snow in alleys.
- Dumping snow or ice on Borough property or plowing snow across a street is also prohibited.

EMERGENCY MANAGEMENT

Emergency Management supports the development and implementation of the Borough of Conshohocken's emergency operation plans and standard operating procedures in large-scale incidents and events. Emergency Management provides support for our first responders and emergency personnel. The department consists of members from the Police Department, Fire Department, Narberth Ambulance, Borough Administration and Public Services, in combination with our Borough Council.

Severe Weather

Thunderstorms – Severe thunderstorms can produce heavy downpours, strong winds, lightning, and hail. Head inside when you hear thunder or receive a Severe Thunderstorm Warning weather alert. Bring inside or secure outdoor furniture. Avoid running water and using electrical appliances or devices that are connected to electrical outlets. **Do not approach downed trees and power lines, report them immediately.**

Extreme Heat – Extreme heat (or commonly known as a heat wave) is a period of temperatures exceeding 90 degrees for at least three days. During an extreme heat weather event, try to stay in the air conditioning as much as possible. If working outside, be sure to wear light clothing, take breaks in the shade often and drink plenty of fluids. Know the symptoms of heat exhaustion and heat stroke. If you or someone near you is experiencing heat stroke symptoms, call 9-1-1.

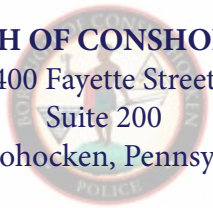
