TAKE A RIDE ON THE CONSHOHOCKEN CAB

The Conshohocken Cab is a new and exciting initiative that consists of a partnership with the Greater Valley Forge Transportation Management Association--a nonprofit organization with over 30 years of transportation planning experience-- and TransNet. The Conshohocken Cab started in February 2024 and stops at 20 locations in a continuous loop in and around Conshohocken Borough.

The Conshohocken Cab is a 14-passenger shuttle that provides easy access to entertainment, dining, large residential complexes, shopping, and the SEPTA train station. The Conshohocken Cab is ADA-compliant, equipped with a bike rack and WiFi.

The Conshohocken Cab's goal is to improve the quality of life of Borough residents by reducing single-occupancy vehicles in the Borough of Conshohocken.

How much does the Conshohocken Cab cost?

Drivers will collect exact change only or contactless payment (Credit/Debit Card with tap to pay, Apple Pay, Google Wallet).

- \$2.00 per ride or 10 Ride Punch Card available on the shuttle for \$10.00.
- Free for minors (ages 17 and under), and they must be accompanied by an adult. If not accompanied by an adult, they must pay \$2.00.
- Free for senior citizens (65+) with a SEPTA pass.

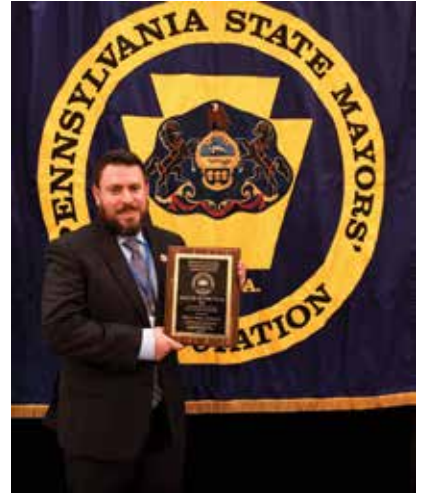
And, of course, Thomas, you have fit right in through your short seven months as a Conshohocken resident. We are so thrilled to share you and your cheeks with all of the Borough.

The Conshohocken Free Library's building was constructed as a home in 1857 by Lewis Lukens, who "contributed greatly to the commercial, cultural, and civic life of Conshohocken."

After his death, his grandchildren gave the house to the Borough of Conshohocken to be used as a library. As their grandfather before them, Lukens' descendants paid it forward to the community, giving them a permanent location to provide opportunities to fulfill the current library mission of providing "lifelong learning for all ages."

In 1973, Conshohocken Free Library became a part of the Montgomery County-Norristown Public Library.

As a branch today, the library receives wonderful support, including funding for our collections and staff salaries. Last year, we received programming costs thanks to Executive Director Karen DeAngelo and the MC-NPL Board of Directors.

The Friends of the Conshohocken Free Library helps support programming and other learning resources. They raise funds through a monthly used book sale and donations. In the spring, they canvas local businesses to support our Summer Reading program and, in return, give back to the local businesses.

The building itself is the responsibility of the community. We own it, and we are responsible for its upkeep. We owe it to the legacy of the Lukens family to pay it forward by providing funding for maintenance, upkeep, and improvements.

Many of those decisions are made by the library's advisory board (a group of volunteers), who donate their time and energy to guide decisions on maintaining the building and to raise funds to support

those efforts.

These are just a few examples of how members of the community pay it forward in the spirit of the Lukens family.

There is always room for more support in our efforts. There are currently financial needs to support upgrading our fire alarm system, replacing the roof, security cameras to monitor the exterior of the building, and everything else that happens in between.

It is important everyone enjoying our library knows the story of the Lukens' generous donation and the condition that if the building ever stops being a library, it goes back to the descendants of the Lukens family.

The Conshohocken Free Library is a nonprofit 501(c)(3) organization. Donations keep our building a library. Donations can be made in person at the library or online.

Let's keep the library standing for future generations to enjoy lifelong learning opportunities. Thank you for your generosity!

ENGINEERING



The Borough of Conshohocken is required to enforce a Stormwater Management Program designed to reduce the discharge of pollutants from the public storm sewer system to protect water quality per the requirements of the Clean Water Act and Pennsylvania Clean Streams Law. The public storm sewer system includes storm sewer inlets, piping, swales, catch basins, channels, and even roads. Pollutants include soil, garbage, sewage, and nutrients found in fertilizers.

As part of this Program, the Borough submits periodic reports to the Pennsylvania Department of Environmental Protection detailing how it complies with 6 Minimum Control Measure categories: Public Education and Outreach on Stormwater Impacts; Public Involvement/Participation; Illicit Discharge Detection and Elimination; Construction Site Stormwater Runoff Control; Construction Stormwater Management; and Pollution Prevention/Good Housekeeping. The Borough also enforces a Pollution Reduction Plan to reduce the amount of sediment reaching Plymouth Creek via the public storm sewer system.



The most important thing to keep in mind is that the public storm sewer system does not get treated - anything that enters the Borough's system will reach the Plymouth Creek or Schuylkill River. Some easy things you can do every day to help protect water quality include:

- Dispose of pet waste in the trash
- Reduce the use of fertilizers and pesticides on lawns and gardens
- Store and dispose of any hazardous products properly
- Mulch lawn clippings back into the lawn to provide natural fertilizer
- Keep leaves and grass out of storm drains
- Place litter in trash receptacles

If you notice water flowing in the public storm sewer system during times of dry weather, this is a potential sign that there could be a problem. Please report any concerns to Conshohocken Borough at 610-828-1092.

ZONING SERVICES

The rules for each zoning district are outlined in the Borough's Zoning Ordinance (<https://ecode360.com/14317188>), which determines the specific land uses that are permitted in each district, such as residential, office, commercial, or industrial. The code also outlines the dimensional standards in each district, such as maximum building and impervious coverage, minimum building setbacks, and maximum building heights.

Zoning Permits:

The Zoning Ordinance includes regulations governing off-street parking, patios, walkways, signs, fences, and accessory structures. Please note these all require zoning permits.

The Zoning Permit application is found on the Borough's website, www.conshohockenpa.gov. The permit fee is a flat fee of \$50.00, and permits require two weeks to process for completed applications.

Zoning Hearing Board Applications:

The Zoning Hearing Board conducts public hearings at the request of developers and residents seeking zoning relief from a provision of the Zoning Ordinance via variance or special exception. The Board meets when an application or zoning petition has been submitted with all applicable documentation and fees. The Zoning Hearing Board reviews applications on a case-by-case basis and makes determinations based on the Borough's Zoning Ordinance.

Meeting dates, changes, and cancellations are reflected on the Borough's website.

Short-Term Residential Rental (Transient Lodging):

Per the Conshohocken Borough Code, the rental of a residential property for a period of less than 30 days constitutes transient lodging and is NOT permitted within the Borough. Therefore, the operation of a short-term residential rental (transient lodging) use constitutes a zoning violation.

HOUSING REHABILITATION PROGRAM

IS YOUR HOUSE IN NEED OF REPAIR?

If you or someone you know needs repairs to their home, consider applying to Conshohocken's Housing Rehabilitation Program. Repairs can include:

The replacement of roofs, windows, and doors.

Improvements to the electrical system and plumbing.

Kitchen and bathroom improvements.

Accessibility of a home can be improved with the installation of grab bars, first-floor bathrooms, and ramps. Any activity needed to comply with the building code can be included in rehabilitation.

To be eligible, you must:

Be a resident of the Borough of Conshohocken;

Own and occupy a single-family residence;

Be current in taxes and sewer fees;

Have household income not exceeding the following:

1-person household - \$62,500 4-person - \$89,250

2-person household - \$72,400 5-person - \$96,400

3-person household - \$80,350 6-person - \$103,550

Tips to Protect Yourself and Your Property

Phishing/Scam Phone Calls

- Avoid scam phone calls by placing yourself on Pennsylvania’s ‘Do Not Call’ list. Pennsylvania’s ‘Do Not Call’ law allows people to register their phone numbers—including cell phones—on a “do not call” list. Telemarketers must update their lists quarterly and are generally prohibited from calling numbers on the list unless they have established relationships with the recipient.
- Find out more information by calling 1-888-777-3406 or visiting www.attorneygeneral.gov/protect-yourself/do-not-call-list/.
- Never give out personal identifying information over the phone. No government agency or bank will call you for this information. Avoid the pressure to make an immediate decision.
- Do not pay utilities, taxes, or fines with a gift card. These are scam callers. No agency like this would request payment in the form of a gift card.

Prevent Theft at Home

- Keep your doors and windows locked when not in use.
- Make sure you have proper lighting on the exterior of your home, both front and back.
- Keep at least one light on inside your home, and do not pull the shades or curtains when you’re not home.
- Install a peephole and verify your visitor before opening the door. All solicitors must register with the Borough. If you would like to be placed on the Borough’s ‘No Solicitation’ list, you can do so by calling 610-828-1092 or visiting the website (www.conshohockenpa.gov)
- When you’re out of town, stop all deliveries and mail.
- Set automatic timers to turn lights on and off while you’re away.
- Request vacation checks from the police department by filling out the ‘Vacation Notice’ Form at the police department or online at www.conshohockenpa.gov/departments/police-services/

Preventing Theft from Your Vehicle

- Park in well-lit areas.
- Lock your vehicle and remove valuables before exiting the vehicle. Never leave your car title or other important documents in your vehicle.
- As always, be vigilant of your surroundings. If you see something that seems suspicious or out of place, always call the Conshohocken Police Department at 610-828-4032.

Police Lobby Resources

Did you know that the Conshohocken Police Department has a medication drop box for unwanted or expired medications? Unwanted medications should be placed in the labeled drop box located inside the lobby of the Conshohocken Police Station. Medication, including prescription pills and patches, over-the-counter medications, vitamins, samples, and pet medicine, are accepted. We do not accept inhalers, thermometers, needles, medications from businesses or clinics, hydrogen peroxide, ointments, lotions, liquids, or aerosol cans.



Also available in the police lobby is a shred bin to dispose of any unwanted documents or paperwork safely and securely.

The police lobby is open Monday through Friday from 8 a.m. to 4 p.m.

Free Smoke Detectors & Installation

Free smoke detectors are available for residential property owners for pick-up at Borough Hall (400 Fayette Street, Suite 200). Supplies are limited to three (3) smoke detectors per household. Residents that require assistance with the installation of smoke detectors can contact Director of Fire Services, Tim Gunning, for arrangements.

Fire Safety Tips

Smoke Alarms

- Smoke alarms should be installed on every level of your home, inside and outside of sleeping areas.
- Smoke alarms should be tested monthly, and batteries should be changed every six (6) months.
- Smoke alarms should be replaced every 10 years.

Carbon Monoxide Alarms

- Carbon Monoxide alarms should be installed on every level and tested on a monthly basis.
- Carbon Monoxide alarms should be replaced every seven (7) years.

Summer Safety

- Fireworks and sparklers can cause fires, burns, dismemberment, or death if handled improperly. Pennsylvania residents are permitted to purchase and use consumer-grade fireworks that contain a maximum of 50 milligrams of explosive material. The use or discharge of all display fireworks or sparklers is prohibited on Borough property and parks.
- Propane, charcoal, and wood pellet barbecue grills should be used outdoors only. Indoor use can cause fire or carbon monoxide poisoning.
- Grills, chimineas, outdoor fireplaces, and fire pits should be at least 10 feet away from your home or anything that can burn. These items should not be stored or used on porches or balconies.



SUTCLIFFE PARK TRAIL RECONSTRUCTION PROJECT

Reconstruction of the Sutcliffe Park walking trail will begin in 2024. The construction will replace the trail's walking surface, improve drainage along the trail, add a new level trail loop to benefit older adults and people with disabilities, and install new benches and signs.

Trash & Recycling Cart Updates

Borough-approved containers must be used for all residential trash and recycling unless other arrangements have been made and approved by the Public Services Department. Trash and recycling cans must have 2 wheels, a metal life bar, and attached lid. Unapproved containers will be tagged for no future pickups until the residence comes into compliance.

Trash Collection Rules and Regulations

- There is a limit of four (4) cans/bags per household per pick-up (200 pounds maximum)
- Each can/bag is not to be heavier than 50 pounds.
- Needles, syringes, lances, and other sharp objects should be placed in a metal container with a secure lid so as not to be a hazard.
- Each household is permitted to dispose of one (1) large piece of furniture or bulk item per month with regular trash. This includes sofas, box springs, plastic siding, TVs and all electronics. All other bulk trash or bulk metal collection must be arranged through the Borough of Conshohocken by calling 610-828-1092.
- Please place your cans/bags at curbside on your property no earlier than 5:00 PM the night before and your cans must be removed from curbside no later than 7:00 PM the day of collection.
- No construction debris, carpet, clean-outs, or move-outs unless approved by the Licenses and Inspections Department. Please call 610-828-1092.

Conshohocken Is Single Stream Recycling

Single stream recycling allows all your recyclable materials to be placed into one recycling container. The best part is you do not have to separate them! Hence, we get the term **'Single Stream Recycling.'** Residents will see trash trucks collecting recyclables. Rest assured recycled materials will go to the recycling facility, NOT the trash-to-steam plant. Recycling carts should be left out before 7:00 AM on collection day, at the front edge of your property or nominated collection point.

Yard Waste Collection Rules and Regulations

Yard waste stickers are available at the Borough office to convert your old blue recycle bin into a container for yard waste disposal.

All residents must participate in the Borough's recycling programs by separating their recyclable material from their regular trash. Yard waste is recyclable; therefore, the separation and collection of this material is mandated by the Commonwealth of Pennsylvania and Conshohocken Borough.

- Weeds, leaves, brush, and plants should be placed in biodegradable paper composting bags. Please, no trash in these bags.
- Each bag should not be heavier than 50 pounds.
- Tree branches under five (5") in diameter, not exceeding five (5') in length, are to be securely tied into bundles and should not be heavier than 50 pounds.
- Christmas trees. No decorations, tree stands or plastic tree bags.
- Please place your bags, and/or bundles at curbside on your property no earlier than 5:00 PM the night before.

Christmas Tree Recycling

Public Works collects Christmas trees each year following the holiday. Christmas trees should be placed curbside the Tuesday before yard waste collection. The trees are collected, chipped, and composted. All tree bags, ornaments, lights, and stands must be removed.

Snow Removal

Efficient snow removal helps ensure the safety of our residents, visitors, and those traveling through the Borough. When it snows, Public Services makes every effort to clear all Borough and state roads within six (6) to 10 hours after snow has stopped falling. Public Services utilizes a snow management plan that consists of pre-treating roads with a brine solution and plowing during and after a snowstorm. Please refrain from parking on the street if you have off-street parking available.

Plowing

Residents with off street parking should refrain from parking on the street so that Public Services can clear more of the road. Cones, lawn chairs or other objects used to reserve parking spaces during a snowstorm are prohibited. Public Services will not stop plowing to remove objects used to reserve parking spaces.

State and Local Roads

Public Services is responsible for plowing all local and state (PennDOT) owned roads, including the Matsonford Bridge and train station cross walks within the Borough of Conshohocken. SEPTA is responsible for clearing snow from the train station and all steps and/or staircases accessing the train station.

Declared Snow Emergency

When the Mayor declares a snow emergency, residents are required to remove their vehicles from any of the Snow Emergency Routes designated below. During a declared snow emergency parking is restricted in these areas and vehicles may be towed.



Snow Emergency Routes

- Fayette Street, both sides from the Conshohocken Borough line to the bridge.
- The south side of Freedley Street from 12th to 11th Avenues.
- Poplar Street from Elm Street to Washington Street.
- East First Ave. (Harry Street to Fayette Street)
- West First Ave. (Fayette Street to Forrest Street)

Snow Removal Reminders for Residents

- Residents should clear their sidewalks after plowing has been completed.
- *It is illegal to shovel, throw or plow snow from sidewalks onto street parking, driveways, allies and into the street or right-of way.*
- Please use caution while shoveling heavy, deep snow from your property.
- A 3-foot-wide path on the sidewalk must be cleared on your property within 24 hours after the snow has stopped. Don't forget your crosswalks, handicapped ramps, and alley crossing. The Borough does not plow snow in alleys.
- Dumping snow or ice on Borough property or plowing snow across a street is also prohibited.

Licenses & Inspections is responsible for the administration and enforcement of Borough ordinances, along with Federal and State building codes. These ordinances may pertain to building, zoning, land development, housing, and property maintenance.

It also responds to citizen complaints concerning property maintenance (lawn maintenance, snow removal, etc.); construction project inspections; apartment inspections; curb and sidewalk inspections, and applications regarding building projects. Licenses & Inspections issues permits for Use and Occupancy, repairs, replacements, additions, and new installations of boilers, roofs, etc.

Licenses & Inspections works closely with the Police Department and the Borough's Fire Marshal in the resolution of health and safety issues as well as residential nuisance complaints on a day-to-day basis.

Frequently Asked Questions

Do I need a permit for...? Any work beyond a basic repair or a non-structural alteration may require a building permit issued by the Borough's Building Code Official for both residential and commercial properties. The best course of action is to contact the Borough at (610) 828-1092 and ask a building inspector if a permit is required for your project. Be prepared to provide a detailed scope of work for the project and identify the property as residential or commercial. Change in use may require zoning approval.

Am I responsible for maintaining the alley behind my house? Yes. Typically, the property owners on each side of an alley are responsible to maintain to the center of the alley for the width of each respective property. This includes the alley pavement surface (e.g. potholes), as well as grass, weeds, trash, etc., that may be found in an alley, regardless of how it ended up there. Weeds on the other side of your fence along the alley are still part of your property, and therefore your responsibility to trim and/or spray. The Borough does not plow snow in alleys.

Why does the Borough need to inspect the home I'm selling? Borough Ordinance Chapter 11, Part 1 governs Transfer of Real Estate and Real Estate Certification. Per §11-111, anyone selling a property in the Borough is responsible to certify that there are no uncorrected violations of any housing, building, zoning, and safety or fire codes. The Borough performs an inspection based on a Real Estate Certification Checklist, which was adopted by Borough Council and records any apparent violations. It is required that all violations be corrected prior to settlement, or the responsibility to correct said violations may be transferred to the buyer, who will have 12 months to complete the work. The terms of such a transfer are private and fall outside of the Borough's authority.

Where exactly is my property line? Absent physically apparent monuments or property corner pins, the Borough cannot independently verify property lines on behalf of private property owners. Property owners are encouraged to engage a Professional Land Surveyor to prepare a site plan and physically set corner markers. This information is useful for locating potential property improvements such as fences and garages, laying out additions to the primary structure, and to satisfy property line disputes, if necessary.

Residential Rental License Permit

A Rental Property is considered, any dwelling, including but not limited to a house, townhouse, row house, duplex, twin, apartment, condominium, rooming house or mobile home, and any building containing any such units, from which the owner derives income or any other consideration from persons residing at such dwelling, as evidenced by a written or oral contract, lease, sublease or agreement. A Rental Property has an occupancy that occurs for a period of 30-days or more. Full Residential Rental Permit License information can be found on our website under resources | Borough Code of Ordinances | Chapter 11 | Part 2.

****Per the Conshohocken Borough Code, the rental of a residential property for a period less than 30-days constitutes transient lodging and is not a permitted use at the referenced property. Therefore, the operation of a short-term residential rental (transient lodging) use constitutes a zoning violation.**

- All owners of rental properties in the Borough of Conshohocken are required to submit a rental application, on or before April 15 of each calendar year, for the issuance of a residential rental license

permit. A separate application is required for each rental property. Application Renewals will need to be completed each year.

- At the time of application, submit all applicable fees, provide a list of tenants; and a completed Borough earned income tax form or an affidavit attesting to the fact that the tenant is not employed.
- The tenant list shall be updated any time that a change of tenant occurs during the term of the residential rental license permit. Failure to update the tenant list will constitute a violation.
- Every application will have an initial property inspection completed by the Borough's Rental Property Inspector. Bi-Annual Inspections will be conducted thereafter.
- Residential rental properties in the Borough of Conshohocken are required to have house numbers installed and maintained on the front and rear of dwelling structures used for residential rental unit(s). The house numbers required by the ordinance must be installed before a residential rental license may be issued or renewed.

EMERGENCY MANAGEMENT

Emergency Management supports the development and implementation of the Borough of Conshohocken's emergency operation plans and standard operating procedures in large-scale incidents and events. Emergency Management provides support for our first responders and emergency personnel. The department consists of members from the Police Department, Fire Department, Narberth Ambulance, Borough Administration and Public Services, in combination with our Borough Council.

Severe Weather

Thunderstorms – Severe thunderstorms can produce heavy downpours, strong winds, lightning, and hail. Head inside when you hear thunder or receive a Severe Thunderstorm Warning weather alert. Bring inside or secure outdoor furniture. Avoid running water and using electrical appliances or devices that are connected to electrical outlets. Do not approach downed trees and power lines, report them immediately.

Flooding – Turn Around. Don't Drown! Do not drive, walk or swim through flooded areas. Never drive around barricades, first responders use them to direct traffic away from flooded areas.

Extreme Heat – Extreme heat (or commonly known as a heat wave) is a period of temperatures exceeding 90 degrees for at least three days. During an extreme heat weather event, try to stay in the air conditioning as much as possible. If working outside, be sure to wear light clothing, take breaks in the shade often and drink plenty of fluids. Know the symptoms of heat exhaustion and heat stroke. If you or someone near you is experiencing heat stroke symptoms, call 9-1-1.
